**To terminate on the 31st December 2024 or on the driver's 11th birthday (Ninja Karts), 16<sup>th</sup> birthday (Junior Productions) or otherwise in accordance with the terms of this contract.**

I understand that I may race a Ninja Kart / Junior Production and confirm that I am competent and capable of doing so. I fully understand the nature and type of racing in which I wish to participate and am fully familiar with the nature, layout, features and geography of the circuits upon which I wish to race.

I, the DRIVER, hereby apply to DMC Race Promotions to race a Ninja Kart on their controlled racing circuits. I am 6 years old or over, but not over 11 (Ninja Kart). I am 10 years old or over, but not over 16 (Junior Production). I understand that this license entitles only the driver to entry to the stadium on dates when racing. I have read this agreement and the DMC Race Promotions Rules and agree to abide by them, and the rules and conditions as set out below.

Parent/Guardian Agreement on page 3 of this contract must be fully completed by Parent or Guardian:

I agree:

*Not to take part, as a person or allow my competition car, my name or racing number to be used with any other promotion advertising, at any time within the dates of this agreement, other than DMC Race Promotions or affiliated racing organisations, or without written permission of DMC Race Promotions.*

*To abide by the rules and regulations at all times as laid down by DMC Race Promotions, ORCi and its Board of Control.*

*I hereby give DMC Race Promotions Ltd the right to use my name or my racing number, and any photographs or video footage of me and or my race car, or similar for the purpose of advertising or publicity as they see fit.*

*I will pay the promotion upon signing this agreement the sum of £45.00 (incl. VAT) DMC Race Promotions will on acceptance of this agreement supply me with my racing number (exclusive to myself for the period of this agreement), one printed Log Book for 2024, notification of my grading and the opportunity to race according to the Rules set out in the 2024 Rule Book.*

*I understand that it is my responsibility to ensure that I receive a copy of the 2024 rules and regulations.*

*New applicants are required to complete a multiple-choice written test and a basic driving skills test before being permitted to race. This must be arranged in advance of your first race, via the Racing Office.*

*I understand that any sponsorship, advertising rights or benefits I might receive from the same, must be with the approval of DMC Race Promotions.*

I understand that any personal injury sustained during racing on DMC Race Promotions / ORCi controlled tracks will NOT entitle me to the personal accident benefits listed in the Rule Book for Drivers aged 18 years and over, but a nominal amount will be paid by the Company's Insurers to a maximum of £1,000 for loss of eyes, limbs or permanent total disablement no other payments whatsoever will be made. DMC Race Promotions accepts no other responsibility other than stated herein.

That except in the case of death or personal injury caused by DMC Race Promotions' negligence, or as expressly provided in this Contract, DMC Race Promotions shall not be liable to me by reason of any representation (unless fraudulent), or any implied warranty, condition or other term, or any duty at common law, or under the express terms of the Contract, for any loss of profit or any indirect, special or consequential loss, damage, costs, expenses or other claims (whether caused by the negligence of DMC Race Promotions, its servants or agents or otherwise) which arise out of or in connection with the provision by DMC Race Promotions of this Contract and the right to race at the Circuits or the use of the Circuits by me, and the entire liability of DMC Race Promotions under or in connection with the Contract shall not exceed the amount of DMC Race Promotions' charges pursuant to the Contract.

Either I or DMC Race Promotions may (without limiting any other remedy) at any time terminate the Contract by giving written notice to the other if the other commits any material breach of the Contract and, if such breach is capable of remedy) fails to remedy the breach within 30 days after being required by written notice to do so, or if the other goes into liquidation, becomes bankrupt, makes a voluntary arrangement with its creditors, or has a receiver or administrator appointed.

This Contract constitutes the entire agreement between us and supersedes any previous agreement or understanding and may not be varied except in writing between myself and DMC Race Promotions.

UK law shall apply to this Contract and both I and DMC Race Promotions Ltd agree to submit to the exclusive jurisdiction of the UK Courts.

I will not cause or be in any way involved in any action that would or could disrupt a race meeting.  
I understand that I am responsible for the actions of my pit crew and family members and acknowledge that if their behaviour in any way disrupts a race meeting, my licence may be suspended or cancelled.  
I authorise DMC Race Promotions to obtain any Incident Report Form in order to process any insurance claims.  
I authorise DMC Race Promotions to use my image/photograph in promotional material.  
I understand that my details will only be held by DMC Race promotions for records and insurance claims purposes.

## Important Driver Guidelines

All drivers must sign in at the Racing Office at every meeting. This is an insurance requirement and there will be no exceptions to this rule under any circumstances.

It is each driver's responsibility to get his/her car scrutineered at each meeting. It is the responsibility of the driver to find the scrutineer, and not vice versa.

All National Hot Rods, 2.0 Hot Rods, Lightning Rods, Stock Rods, 1300 Stock Cars, Junior Productions, Ninja Karts and Superstox must have a fully operational transponder fitted, otherwise they risk not being scrutineered or lap-scored.

All cars must have numbers displayed on both sides of the car, and also a fin plate at roof level. Failure to comply with this rule could mean not being lap-scored.

(Please refer to 2024 Specifications for each formula for number requirements).

Drivers are not allowed to exit their cars whilst the race circuit is live i.e., under "green" racing conditions. This includes both drivers on the race track whose cars have become immobilised and those who retire to the infield who must also remain in their cars with both their safety harness and helmet on. The only exception to this is where a car needs to be vacated in emergency conditions – i.e., fire etc.

Any driver who requires medical attention, or who signals to a marshal to stop/suspend a race because they are injured, will not be permitted to take part in the remainder of that meeting, and may require a medical certificate to compete at any subsequent meeting.
